Introduction

We have had a run of very positive inspections and now is a moment to take stock. Ofsted Inspectors at Yatton Infants, West Leigh Infants, High Down Infants and Wraxall CE Primary School have offered very positive and constructive feedback on the quality of leadership, curriculum and teaching at the schools. The West Leigh report has just been published and is one of the most characterful and vivid of the current crop - do have a look. I am also very pleased to congratulate colleagues at Yatton CE Junior School and Winford CE Primary School on their very positive SIAMS feedback following their inspections last week. Overall, a very positive picture of high-quality leadership and governance, skilled teaching and comprehensive safeguarding and pastoral care is building up about our schools. The credit goes to our Heads in particular who always tackle challenges, no matter how difficult, as soon as they emerge. I am probably one of the few Trust CEOs who would love Ofsted to come and do a MAT Summary Evaluation on us. Bring it on!

The other bit of (relatively) good news is that after all the briefing to the contrary, the Chancellor did agree additional spending for schools in the Autumn Statement. You will see Louise's note on this later in the bulletin. We still face some austere challenges and nobody should think that higher wages and pension costs will not erode our budgets, but it is not quite as bad as we had feared. I am thinking that perhaps this gives us a bit more time to make changes more strategically.

We have a Heads meeting face to face in Nailsea tomorrow. It will be great to see everyone.

Autumn Statement

As you may know, the Chancellor announced in the Autumn Statement that schools will get an extra £2.3 billion in 2023-24 and 2024-25. However, we understand that this will actually be a £2 billion increase after the removal of compensation for employer costs of the Health and Social Care Levy is taken into account.

We have no details yet on how this will be distributed to schools, but have completed a rough estimate. If all funding factors were increased consistently, we estimate that you could add 3.62% to the funding you've already estimated for 2023-24 and add 3.52% to the funding that you have already estimated for 2024-25. As soon as we have further information, we will share it with you.

We would, however, like you to treat the increase detailed above with some caution if you wish to factor it into your budget planning.

The teachers' pension scheme is being revalued from April 2024. Last time the was revalued, employers' contributions increased by over 7% and the Government provided a grant to fund it. We are a little concerned that the Government will say that any increase to employers' contribution rates has to be covered by the additional funding they have announced. Unfortunately, we won't know about it until nearer the time.

We have also built in future pay awards of 3% in 2023-24 and 2% in 2024-25 and an increase in employers contributions to the Local Government Pension Scheme of 2% from April 2023. All of these assumptions could be too low, and we anticipate no further funding, beyond the £2m recently announced, to cover any further increases.

We will undertake some further modelling and provide schools with a more prudent funding increase to incorporate as you start to plan for next year and beyond.
