Core Services Charge consultation for 2023-24

The Board of Trustees were due to agree the core services charge consultation at their meeting on 18th January and for the consultation to begin with schools on 19th January. The board agreed to delay this process to enable an additional staffing and pay committee meeting to agree the structure of the Education Team and, subsequently, for the Finance Committee to agree the budget and proposed Core Services Charge for consultation on 31st January.

We now plan to commence consultation on the Core Services Charge for 2023-24 on 2nd February with an end date of 17th February. The results of the consultation will be considered by the Board of Trustees, and a decision made on the Core Services Charge for 2023-24 on 1st March.

I recognise that this reduced the period that you have to consider the proposals and apologise for any inconvenience. Equalities and Diversity Draft Policy

The <u>attached policy</u> has been approved for consultation by the Board but now requires your scrutiny. It is a contested but massively important area and the issue of gender identification is particularly controversial. I fear that I may have favoured it at the expense of other topics. Youi will see that this is a whole Trust policy but I envisage that most of our schools (all but the smallest) will set additional local Equalities Objectives and Monitoring Plan.

Critical incident and business continuity plan template

Consultation on the review of the business continuity and critical incident plan was due to commence in December. This was delayed waiting for a new template that was being devised by One West and to gather feedback from schools on how the current plan has been used. We have now gathered some feedback and received and reviewed the new template from One West. The new critical incident and business continuity plan template is now available for consultation.

The new template is much shorter than the previous version and, we hope, will be more effective in both planning for, and, managing an incident.

We would like to encourage Headteachers and School Business Managers to participate in this consultation. We would also like Chairs of Local Governing Bodies to ensure that the consultation is reported to their LGB and any response from the LGB is noted in their minutes. Chairs may wish to identify a member(s) of the LGB to lead on making a response to share the workload and benefit from governor skills. The Headteacher and Chair of the LGB may also want to consider sharing the consultation with other stakeholders.

The consultation will close on $3^{\rm rd}$ March and the update plan template will be considered by the Audit and Risk Committee on $16^{\rm th}$ March.

We also have hard copies of the LSP Summative Assessment System available - we would like all teachers and school leaders to have a copy. We gave lots to staff who came to moderation, but if you would like more, please let us know how many and we will get them to you.
