Changes to National Insurance Rates & SMP rates on Orovia - action required

Orovia has updated the National insurance rates for the 23/24 financial year. There hasn't been any update to the employer's threshold allowance, and so there shouldn't be any impact on your budgets.

They have also updated the SMP value in the system so that it reflects the increase to £172.48. This will impact any live budgets that you have with members of staff on maternity leave and you will notice a slight difference in costings once you have regenerated your employee scenarios and repopulated your budget forecasts. It is essential that this is updated to ensure that your budgets are as accurate as possible, so please regenerate your current working scenario on Orovia as soon as possible and in time for your next budget monitor.

IMP has not yet been updated, but we will advise schools when this has been actioned. Thank you.
