### Introduction

As ever Term 2 is off to a flying start! Ofsted are visiting Blagdon this week (today is the second day of inspection). Colleagues at Blagdon have been working and preparing for this for a very long time and are in a strong position so the inspectors have been very welcome this week.

We have a number of consultations scheduled this term:

- Hannah More and Grove (Whiteoak Academies) are <u>running a consultation</u> for a new Resource Base on their school site. This would offer specialist speech, language and communication provision to 10 primary aged children with Educational Health Care Plans. A public information session is being held at Grove Juniors on Monday 6 November from 6.30pm and the initial consultation and feedback period closes on Friday 10 November.
- The LSP will begin the consultation period on the Admission Arrangements for 2025-26 later this month. This is being handled centrally so we will ensure all stakeholders are updated and included directly in this consultation so there is nothing further for individual schools to do at the moment.
- We also have a number of policy publications and consultations over the next few weeks, including the Complaints Policy. Please keep your eye on future bulletins for more details on these, including how to give your feedback.

Plans are also well underway for the joint INSET days later in November:

- Thursday 17 November primary colleagues have a day focussing on pedagogy with Tom Sherrington (more details below)
- Wednesday 22 November secondary colleagues will spend the day together in teaching and learning workshops and subject networks.

Finally I would like to take this opportunity to welcome Leah Evans to the LSP Central Team. Leah is our Communications Officer working Tuesday, Wednesday and Friday mornings. These weekly bulletins will shortly come to you directly from her email address and not mine.

### Reminder: Autumn School Census 2023

The 2023 autumn school census date was Thursday, 5 October. The deadline for returns is to-day: Wednesday, 1 November.

The school census data will be used to finalise funding allocations. It is important that you <u>run</u> <u>and check your reports</u> carefully to ensure the data submitted is correct. Submitting inaccurate data risks your funding allocation being lower than it should.

Full guidance to help with completing the census is available on GOV.UK.

## Outcome of the valuation of the Teachers' Pension Scheme

The Department for Education (DfE) has published the outcome of the valuation of the Teachers' Pension Scheme.

The outcome confirms a need to increase the employer contribution rate by 5% from 1 April 2024 to ensure that the Scheme continues to meet present and future obligations. The DfE has confirmed that it will provide additional funding to cover the increase in the employer contribution rate from April 2024. The costs for future years (from 2025/26 onwards) will be considered as part of subsequent spending review rounds. Details of the funding package have not yet been published but are expected to be similar to the formula methodology used recently for the increase in teachers' pay.

We are not planning to make any changes in IMP for this until we see the details of the grant methodology. We can then make the necessary changes to reflect both the increased income and expenditure.

## **Appraisal Policy Working Party**

This year the LSP will be completing a review of the current Teaching Staff and Headteacher Appraisal Policy and Procedures with a view to updating this policy ready for launch and implementation from September 2024.

Neil Lankester, Director of School Improvement, will be leading this process and is forming a working party which will meet online around 3-4 times across the year as we work through the process. We are looking for around 6-8 volunteers to join the group to represent colleagues from both primary and secondary schools and ideally this will involve at least 1 of each of the following:

- Primary Headteacher
- Secondary Headteacher
- Head of Department (Secondary)
- Primary School Teacher
- Secondary School Teacher

The first meeting will be held on Thursday 7 December from 3.00-4.00pm. If you are interested in joining the group please email Neil directly by Monday 20 November.

## Safeguarding Declaration for Governors and Trustees

## GL Assessments for Dyslexia and Dyscalculia

As part of a school's graduated response to dyslexia/ dyscalculia, some schools are using a screener to highlight need before making a referral to an Educational Psychologist. The graduated flow chart of dyslexia/ dyscalculia was shared in SENDCO networks last year.

## **Funding Allocations**

The Department for Education (DfE) have published a number of funding allocations as outlined below. We have downloaded the allocations to Foldr for ease (under 'Information for 2023-24 budgets'). Please review the allocations to ensure you are using the most up-to-date information for your October Budget Forecast.

All of the links below are to Foldr and the documents can be found in the following section: School Business Managers >Trust Wide > Information for 2023-24 Budgets

**Pupil Premium** - the download includes the number of pupils eligible for the Deprivation Pupil Premium (based on the October 2022 census) and will determine your income for 1 September 2023 until 31 March 2024. It does not include service pupils or PLAC pupils. Please use this information to update Pupil Premium pupil numbers in your IMP Master Scenario.

It is Funded Pupil Premium Numbers Primary/Secondary for 2022/23 that you are reviewing rather than overriding the calculated value for funding. If you have not already done so, you should use your October 23 pupil census to estimate pupil numbers for 2023-24.

### Foldr link for Pupil Premium Information

Covid-19 Recovery Premium - the allocations have been published for Recovery Premium for the 2023-24 financial/academic year which will be paid in four instalments on nominal code 1058. This funding is focused on pupil premium eligible pupils because of the additional impact of the pandemic on these students. However, schools can use it to deliver evidence-based approaches for supporting any pupil based on an assessment of individual need.

Recovery premium allocations for mainstream schools will be based on pupil premium eligibility. Recovery premium allocations will be calculated on a per pupil basis, based on £145 per eligible pupil in primary schools and £276 per eligible pupil in secondary schools. There continues to be a minimum payment to ensure that eligible primary and secondary schools will not receive less than £2,000 and £6,000 respectively. Funding for looked-after children will be paid to the local authority and should be managed by the virtual school head in consultation with the child's school.

### Foldr link for COVID-19 Recovery Premium

**Teachers' Pay Additional Grant (TPAG) 2023-24** - allocations for September 2023 to March 2024 have been published and will be paid to schools in November. Please review the TPAG grant estimated in your Master Scenario on IMP under nominal code 1045 and ensure you include a value for 12 months. TPAG will continue to be paid as a separate grant for the whole of the 2024-25 financial year as well after which it will be rolled into core budget allocations.

Schools should therefore continue to project TPAG across all years until more information becomes available.

### Foldr link for Teachers' Pay Additional Grant (TPAG) 2023-24

Mainstream Schools Additional Grant (MSAG) - allocations have been published for the period September 2023 to March 2024 and will also be paid in November on nominal code 1023. As above for TPAG, please review the MSAG grant included in your Master Scenario on IMP and ensure that you include a value for 12 months until August 2024.

MSAG will be rolled into core funding allocations from 2024-25 onwards (although schools should continue to project MSAG across all years until 2024-25 funding is finalised).



## 'School Improvement Snippets' - Effective Checking for **Understanding**

In my final section on effective questioning in the classroom I have attached below a '1 pager' on checking for understanding.

When done effectively, checking for understanding allows the teacher to deliberately and systematically 'check in' with pupils across different attainment groups within the classroom to see how they are keeping up with the learning. This checking should support teachers to make decisions about what to do next - carry on with the lesson or clarify and spend longer on the point being taught as children have not quite got it yet. The 1 pager points to Rosenshine's Principles of Instruction and the need for 80%+ to achieve the success rate in order for the teacher to move on.

I really like the procedure around whiteboards that is indicated as this is also one of the Walkthrus that lots of schools are working on at the moment across the Trust.



I know the idea is simple but when used effectively by teachers it allows the teacher to actually see what all children are thinking at once rather than 'guessing what is in their heads'. It also builds in accountability for pupils - 'I have been asked to do something, I need to show what I know' so therefore supports positive behaviour for learning as part of a culture of positive behaviour management. As teachers become more experienced in the use of whiteboards the key becomes how they are used through live feedback and probing questions.

## Checking for Understanding

Guide the direction of teaching and remedy common misconceptions

### Checking for Understanding

Checking for Understanding (CFU) is a fundamental aspect of effective teaching. It involves teachers consistently finding out what students know about the material being taught. Checking for understanding serves as a means for teachers to adjust their teaching methods and improve learning by assessing student understanding in real time, allowing them to make necessary instructional decisions such as re-teaching during the lesson.



### Rosenshine's Principles of Instruction

According to Barak Rosenshine in his 2012 article, 'Principles of Instruction' effective teaching involves asking questions and checking students' responses to help them practice new information and connect it with their prior knowledge. Rosenshine's research suggests that teachers should ask questions during instruction to facilitate the practice of new material. The most effective teachers engage all students by having them share answers with peers, summarise key points, write responses, or express agreement with others.





CFU guarantees high student success rates. Aim for 80% + so that you can respond and adjust your teaching.





The least effective teachers only asked 9 questions in an entire lesson resulting in more error prone learning.





The most effective teachers spent 23 of a 40 minute lesson explaining, questioning, & giving working examples.



Questioning
A straightforward and effective methods for assessing student knowledge is through questioning. Teachers can employ various questioning strategies to gauge understanding. These include cold calling students and asking follow up questions to probe their knowledge such as, "Why though with the programment of the property of the property of the property of the property of students' understanding and help them connect their knowledge to existing schema. connect their knowledge to existing schema.



Frequently having students summaris Frequently having students summarise what they are learning is a highly effective method for improving their understanding and memory of new information. Additionally, it allows teachers to gauge whether students have a firm grasp of crucial concepts. By observing which topics students either avoid or find challenging to summarise, teachers can identify areas that may need further attention in the next lesson. Ask students to verbally summarise the main steps or write key ideas in dot point form.



### Choice Statements

Present students with a few choice statements or questions and have them select a response. For example, 'True or False', 'Agree or Disagree' and share it via a mini-whiteboard, or hand signal (thumbs up or down). This efficient technique is particularly effective to use in checking students' prior knowledge or potential misconceptions before beginning new instruction if talso pashles learners to felaborate. instruction. It also enables learners to elaborate on the material and "augment connections to other learning in their long-term memory."



Plan the questions Responses should be simple (e.g. write letters for MCQs) Create a signal for the procedure. (e.g. '3, 2, 1... Show Me!')



Stand in an optimal check all responses

Give live feedback as you check.

Another highly efficient and effective method for checking students' understanding is through students' understanding is through identifying and correcting common misconceptions. This involves presenting students with a common misconception or procedural error and evaluating their ability to identify and rectify it. Collect whole-class responses or circulate the room purposefully checking students' work and providing feedback on how to rectify specific errors.

Getting students to draw or create visual representations, such as graphic organisers and concept graphic organisers ain-maps, can be useful in checking the depth of their understanding. Have students create a visual or symbolic representation (for example a graphic organiser, simple table, concept map) of information and

abstract concepts and then be

prepared to explain their graphic to a partner. Picturing techniques are especially useful to see if students understand how various concepts or elements of a process are related. Model this

process over time so that students know how to create effective visual maps independently. For example in English: Ask students to draw a visual web of factors influencing the growth of a protagonist in a novel

### Use short informal assessments

Use short informal assessments, such as quizzes or exit tickets to check the depth of students' understanding. Conducting weekly (or even monthly) low stakes quizzes is an effective method of checking understanding and monitoring students' progress. Try simple paper quizzes or whole class quizzes using digital tools (such as Quizizz) to get more nuanced data on all students.
